QUESTIONS/ANSWERS:

1. Looking through the drawings I do not see much information about the kitchen. There are no elevation drawings that show the extent of millwork or a list of kitchen equipment. I do not see anything for the islands or the serving counter. Also, in room 107, the community room, it does not show furring out the exterior wall on the north side of the room. How does the new ceiling grid tie into this area?

ANSWER: See attached kitchen equipment list.

The serving counter is stainless steel with the top of counter being at 34" above finish floor.

Furr out columns as needed with the gypsum board extending 6" above the ceiling.

2.	is project on trust land?
	ANSWER: This is TRUST Land.
3.	Are all special inspections and testing costs by owner or general contractor? Project manual identifies an allowance in 012100 but that specification section is not in the project manual.
	ANSWER: The General Contractor will be responsible for all testing cost and providing those results to the Cherokee Nation Representative.
4.	Will there be any owner activities at the building during the course of construction? Community events, etc.?
	ANSWER: Mainly on weekends and Holidays, however the contractor will leave the facility in a safe and clean manner every evening. Weekday activities are very limited, and the contractor will work with the owner in advanced in the rare event one a weekday is scheduled.
5.	Is all new kitchen equipment provided by owner and installed by contractor?
	ANSWER: All new kitchen equipment is provided and installed by the contractor.
6.	If contractor is responsible for any kitchen equipment, please provide a complete kitchen equipment schedule.
	ANSWER: See attached kitchen equipment list.

Are wood doors to be factory finished or field finished? Standard colors or full mfg colors?
 ANSWER: Factory finished. Provide full mfg color selections.

8. Please provide specifications for coiling doors.

ANSWER: See attached coiling door specifications.

9. Will any doors on the project require access control? If so, please provide the hardware schedule.

ANSWER: There is no access control at the doors. Refer to door schedule on sheet A1.00.

10. Finish schedule item SC (sealed concrete) lists StoneCrete/Amber. This appears to be an epoxy flooring system and not "sealed concrete". Please confirm.

ANSWER: This is an epoxy flooring system and not "sealed concrete".

11. Please provide details and materials for countertops at coiling doors.

ANSWER: The countertops at the coiling doors are stainless steel.

12. Plans reference partition details on A5.00 but there is no sheet A5.00 in the index or in the drawing set.

ANSWER: See attached Sheet G0.00 with the revised sheet and A5.00.

13. Please provide species of wood door.

ANSWER: White Oak

14. Please confirm extent of FRP in Rm 103. Is this on exterior and east wall only?

ANSWER: All walls should receive full height FRP. Omit P01.

15. Additional Items:

a. See the attached geotechnical report that was completed for the adjacent property.

NOTE FROM OUR CIVIL ENGINEER:

Kalvin,

The geotech report would work as a good guideline for our site and we would recommend including it in any Addendum for the Contractors. For the pavement work, of course, we would recommend having a geotech on site to test the soils and compaction at this site and make recommendations during construction. The geotech on-site may identify that the existing soil material is suitable for scarifying and compacting, however, if the conditions are similar to the area adjacent site where the Geotech Report was prepared, the fatty clays may be an issue and the recommendation would be to undercut 8" and import 8" of suitable fill to place and compact. Based on rough calculations, there is approximately 14,000SF of new pavement, equating to approximately 350 CY of imported fill. I estimate on the high side that this would cost \$20,000 to import 350CY of suitable fill.
